YOU MUST USE A SEPARATE FORM FOR EACH OWNER OR PARTNERSHIP

This form must be used by one person only (or partnership). Writing must be in INK or INDELIBLE PENCIL. Use one line only for each dog. The name of the dog and all the details as recorded with The Kennel Club must be given on this entry form. If an error is made the dog may be disqualified by the Committee of the Kennel Club. All dogs must be REGISTERED at the Kennel Club in the name of the exhibitor. If the registration or transfer of ownership has not been confirmed it must be applied for before the closing date of entries. In case of dispute proof of postage of such applications may be required by the Kennel Club. Puppies under 6 months of age on the first day of the Show cannot be entered for competition. On no account will entries be accepted without fees. If a dog is in the process of Registration or Transfer at the time entry is made, add the letters NAF or TAF as appropriate after its name. Please put classes in numerical order and USE BLOCK CAPITALS throughout when completing this entry form. *The Kennel Club Authority to Compete number (for dogs registered and resident outside the UK) must be stated or the entry will be returned. PLEASE CHECK ALL DETAILS BEFORE POSTING.

DECLARATION I/We agree to submit to and be bound by Kennel Club Rules and Regulations in their present form or as they may be amended from time to time in relation to all canine matters with which the Kennel Club is concerned and that this entry is made upon the basis that all current single or joint registered owners of this dog(s) have authorised/consented to this entry. I/We also undertake to abide by the Regulations of this Show and not to bring to the Show any dog which has contracted or been knowingly exposed to any infectious or contagious disease during the 21 days prior to the Show, or which is suffering from a visible condition which adversely affects its health or welfare, or to bring any dog which has been prepared for exhibition contrary to Kennel Club Regulations for the Preparation of Dogs for Exhibition F (Annex B). I/We agree without reservation that any Veterinary Surgeon operating on any of my/our dogs in such a way that the operation alters the natural conformation of the dog or part thereof may report such operations to the Kennel Club. I/We declare that where any alteration has been made to the natural conformation of the dog(s) the relevant permission to show has been granted by the Kennel Club. I/We further declare that I believe, to the best of my knowledge, that the dogs are not liable to disqualification under Kennel Club Show Regulations.

REGULATIONS FOR THE PREPARATION OF DOGS FOR EXHIBITION F (Annex B)

1. These Regulations must be observed when a dog is prepared for exhibition and/or exhibited at any Kennel Club Licensed event. Objections may be referred to the General Committee for disciplinary action under these Show Regulations and/or for disciplinary action under Kennel Club Rule A 42.
 - a) A dog found to have been exhibited in breach of these Regulations will automatically be disqualified from exhibition at the show and from any award gained thereat.
 - b) Unless the exhibitor provides a satisfactory explanation for the dog being exhibited in breach of these Regulations then he/she may be subject to further penalties of either a fine or as listed under Rule A 42.
2.
 - a) No substance which alters the natural colour, texture or body of the coat may be present in the dog's coat for any purpose at any time during the Show. No substance which alters the natural colour of any external part of the dog may be present on the dog for any purpose at any time during the Show.
 - b) Any other substance (other than water) which may be used in the preparation of a dog for exhibition must not be allowed to remain in the coat or on any other part of the dog at the time of exhibition.
3. No act or operation which alters the natural conformation of a dog or any part thereof may be performed except:
 - (a) Operations certified to the satisfaction of the General Committee.
 - (b) The removal of dew claws of any breed.
 - (c) Operations to prevent breeding provided that such operations are notified to the Kennel Club before neutered dogs are shown.Nor must anything be done calculated in the opinion of the General Committee to deceive.
4. The General Committee without previous notice may order an examination of any dog or dogs at any Show. Any examination thus ordered will be made by a person having executive authority who shall have a written directive from the Kennel Club in their possession. Samples may be taken for further examination and analysis.
5. An individual has the right to lodge an objection to a dog only if he/she is the owner or handler of a dog competing in the same breed or class. An objection may, however, be lodged by an official of the Show or by anyone so deputed by the Kennel Club. It will be the responsibility of the individual who lodges the objection or the official (as appropriate) to substantiate the grounds for the objection. The Kennel Club will substantiate the grounds for an objection made on its behalf.
6. Any objection by an individual related to an infringement of these Regulations must be made in writing to the Show Secretary at his/her office before the close of the Show and the individual must produce evidence of identity at the time of lodging the complaint.

Your dog is vulnerable and AT RISK if left in a vehicle in high temperatures and even on days considered as slightly warm. Please take care of your dog. If your dog is found to be at risk forcible entry to your vehicle may be necessary without liability for any damage caused.



Kennel Club Breeders' Competition 2010

The Breeders' Competition offers the following Awards:

Best Breeder in Breed

Best Breeder in AVNSC Classes

Best Breeder in Group 1st, 2nd, 3rd and 4th

Grand Final at DFS Crufts 2011

The following requirements apply to entries for these awards:

1. Breeders wishing to enter the competition should first purchase a Breeders Competition Record Book from the Kennel Club or from the show secretary.
2. The Breeder enters for the award in his/her name and is responsible for arranging which exhibits form their breeder group, or team
3. The Breeder must complete the Record Book accurately with all necessary details before presenting it to the show organisers.
4. The Breeder is responsible for obtaining the necessary authority to compete from the show organisers (or designated official such as the Ring Steward) to compete for the award.
5. The Breeder's team must comprise four exhibits of the same breed, all of which must be entered in a class at the show.
6. A Breeder may enter more than one team per show.
7. All dogs must have the same registered breeder.
8. The 'beaten dog' rule will NOT apply.
9. Best Breeder in Breed and Best Breeder in AVNSC Classes goes through to a Best Breeder in Group award.
10. Breeders acquire points in competition over a calendar year as follows:

Breed win	1 point
Win in AVNSC Classes	1 point
Fourth in Group	1 point
Third in Group	2 points
Second in Group	3 points
First in Group	4 points

The thirty Breeders who have amassed the highest number of points over a calendar year will qualify for the DFS Crufts Final in the following year. At the end of the competition year in question, Breeders should forward their record books to the Canine Activities Department at the Kennel Club which will advise whether they have qualified for the DFS Crufts Final.
